The season is broken down into 3 billing terms:

- Term 1 - Sept 20/10 to Dec 12/10 - Due the day you register
- Term 2 - Dec 13/10 to Mar 20/11 - Due on or before Dec 05/10
- Term 3 - Mar 21/11 to June 09/11 - Due on or before Mar 13/11

ADMINISTRATION FEE – A non-refundable \$15 fee is collected at the time of registration (per season, per family).

Whether you're new to the dance world or a student starting for the first time, here's a great way to participate on a trial basis without having to commit to a billing term.

DROP-IN \$15

Perfect for those who cannot attend class on a regular basis. Arrangements must be made with the office before attending any class.

COSTUME DEPOSIT

JDD collects a \$50 costume deposit with December's payment for every class that participates in the annual dance recital. **This is not the cost of the costume.**

Classes highlighted in the 2010-2011 schedules do not participate in the annual dance recital.

THERE ARE 2 PAYMENT OPTIONS please see fee charts above

OPTION 1 – Per Billing Term (3 installments)

Term 1 - \$15 admin fee + Term 1 payment.

Due the day you register

Term 2 - \$50 costume deposit(s) + Term 2 payment

Due on or before Dec 05/10

Term 3 - Term 3 payment

Due on or before March 13/11

OPTION 2 – Monthly by cheque (9 installments)

First month's payment must be dated the day you register and include the \$15 nonrefundable admin fee. The remaining 8 cheques must be dated for the 15th of the month starting October 15th, 2010 up to and including May 15th, 2011. Please add \$50 costume deposit(s) to your December 15th cheque.

NOTE: If paying by cheque JDD requires Term 1 payment along with 2 postdated cheques for Term 2 (dated Dec 05/10) & Term 3 (dated Mar 13/11). Please let us know if you'd prefer to pay with cash.

NOTE: JDD requires your 1st payment accompanied by 8 postdated cheques upon registration.

FEES ARE NON REFUNDABLE WITHIN A BILLING TERM

2010, 2011 FEE POLICIES & RECITAL COMMITMENT

FEE COMMITMENT - The dance school season is from September 20/10 – June 09/11 and is broken down into **3 billing terms (3 equal payments)**. It is assumed when a student registers, they are registering for the full dance season. However, your commitment is a **billing term**. Withdrawal from classes can only be done at the end of a **billing term**. Notice of withdrawal must be done in writing 2 weeks prior to the next billing term. Postdated cheques given for other terms will be returned.

PAYMENT METHODS – Cash or cheque payable to JILL DREADDY DANCECO **Please write children's name on 'memo' line of all cheques.**

Payments can be made during office hours or by mail if paying with cheque/money order.

CANCELLATION FEE – As mentioned in 'Fee Commitment' above there is **no refund within a billing term** therefore all 3 installments will be deposited. Cancelled cheques within a **billing term** will result in a \$25 cancellation fee.

REGISTRATION - Students must be registered and fees paid prior to their first class. Registration is accepted throughout the season space permitting. Registration hours begin Aug 25th for returning student's and Aug 30th for new students.

REFUNDS - Refunds are given only in the event of cancellation due to insufficient registration or illness/injury with a medical note from one's doctor. Refunds are effective from the day classes are cancelled or we receive a medical note. There is no refund for classes missed by a student throughout the season. Students are welcome to make up classes missed within that **billing term**. Please make arrangements for makeup classes with your instructor prior to the class.

LATE PAYMENT CHARGE - A fee of \$15 will be added to your account if fees have not been received within 14 days from due date.

NSF CHEQUES - If any cheque paid to the studio is not honored by the bank, replacement payment, plus a \$25 NSF charge must be made by cash, certified cheque or money order within 10 days of notification

INCLEMENT WEATHER - We announce closure of the studio on most radio stations and on our voicemail. Please confirm cancellation of classes by calling the studio 1 hour prior to your class. Students are encouraged to make up classes by making arrangements with their teachers. We do not reschedule classes.

Christmas Break December 22nd, 2010 to January 4th, 2011 (inclusive)

Easter Break April 20th, 2011 to May 3rd, 2011 (inclusive)

FITNESS TAX CREDIT – You can claim up to \$500 (per child) on your income tax return for children under the age of 16yrs who take classes at JDD. Receipts are emailed to students unless you request otherwise. JDD cannot reissue receipts...it is the students responsibility to keep copies of receipts.

RECITAL COMMITMENT

Younger children participate in only 1 show.

Students are encouraged to participate in the dance recital but it is not mandatory.
If you are **not** participating in the dance recital you must notify us when you register.

COSTUME DEPOSITS

A \$50 costume deposit is due with December's payment for each class that participates in the recital.

Please note that the deposit collected is not the price of the costume but a deposit towards it.

Once costumes are ordered they are the student's responsibility and must be paid for in full.

An invoice for the balance is sent home once all costume items have been ordered or purchased.

Costume deposits are nonrefundable after Dec 15/10

VIDEO AND PHOTOGRAPHS

JILL DREADDY DANCECO may video or photograph students in class for the purpose of promotion and advertising.
Unless notified in writing JDD will assume that such photographs or video may be used for publicity purposes.

Video and photos are strictly prohibited by observers during class without the permission of the teacher.

UNIFORMS & DRESSCODE REQUIREMENTS

JDD has a uniform for TIM, M&M, Tap, Jazz and Ballet classes and a specific dresscode for all other classes.

Uniforms must be worn to class every week. Please see the website for details.
